What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The investments in this equity Sub-fund are actively managed with the aim of achieving commensurate, long-term capital appreciation. The Sub-fund is actively managed without reference to any benchmark. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund invests at least 60% of its net assets in equities and equity-type securities that address global themes such as the energy revolution, circular economy, mobility solutions, megacities, and quality of life. Up to 40% of net assets can be invested in cash and cash equivalents, and up to 20% in structured products. The Sub-fund invests without being restricted to a certain country, region, or currency. Investments in Chinese securities are conducted via the Stock Connect link and involve the specific risks applicable to this market. More than 50% of the Sub-fund's assets will be invested on an ongoing basis in equity participations within the meaning of German Investment Tax Act ("GInvTA"). Derivatives can be used for hedging against price and currency fluctuations as well as for investment purposes. Investors can subscribe or redeem shares on any bank business day in Luxembourg. This share class is not entitled to regular distributions. The Sub-fund bears the costs of standard brokerage and bank fees on securities transactions for the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator.
